

Share an application with a consultant in PharmConnect

Important things to know before you start

The consultancy preparing the application needs to be [registered under its own name in PharmConnect](#).

For each application you want to collaborate on, you need to follow the process detailed below to share it with them.


Any staff at the consultancy who are registered in PharmConnect will be able to see the applications you share with their organisation.

Once shared, the application will display on the 'My applications' list for the consultancy that is preparing your application. They will be able to edit it only – they do not have the ability to submit, withdraw, delete or re-share the application on your behalf.

Once you submit the application to Pharmac, the consultancy will no longer be able to see it.

Create your draft application

1. Using Google Chrome, Microsoft Edge, or Firefox, [log in to PharmConnect](#).
