- PHARMAC enquired about the possible availability of Nimenrix MenACWY vaccine for use in Northland.
- CM advised Pfizer do have some stock, but not much in NZ. Have just started a Government programme in Australia.
- Could supply some doses, but need to gather more detail on timing of supply and the number of doses available.
- CM reported that both Menactra and Menveo meningococcal vaccines were out of stock in Australia.
- CM to check the price.
- CM noted another shipment is due to land in Australia next week. There might need to be a phased supply.

- CM advised that Pfizer could supply up to 33,000 doses of Nimenrix. The vaccine is available in Australia currently, in harmonised AU/NZ pack.
- The price would be \$68.95 +GST per dose.
- CM advised the only caveat is that this offer is available right now, they could get unplanned demand from Australia which could use this stock. So the availability would need to be reconfirmed when ordering.
- CM noted it typically takes about 2 weeks to ship stock across from Australia.
